3. Approval of the minutes of the last AGM held on 27/11/2019

These were approved subject to the correction of an error on page 7 in the last paragraph which should read;

"If we produce a new facility and we are funding it, then there is no way that they are getting a new lease *at the same rate.*"

5. Approval of the Annual Accounts

Keith Morgan noted that the trade debtor was quite high, this was because the first quarter was during a lock down and it was agreed with Cardiff Rugby that as they had no income at that time they could defer the payment of the rent. It was agreed that all arrears were paid before the first quarter was due. As a result of the arrangement Cardiff Rugby have paid all outstanding rent and now pay on a monthly basis.

6. To Elect the President

Our previous president has come to the end of his term as President and thanks was given to Mervyn Warfield for his time and to wish him well for the future.

The Management Committee proposed Mr Alun Priday the new President. Alun has played both Cricket and Rugby for Cardiff and for a number of years was the Club Secretary. He is a Club stalwart through and through,

This was unanimously agreed by the meeting.

Mr Alun Priday stated that "It is an honour, and I am greatly obliged to both the Chairman and the committee for their confidence. I hope that I can fulfil the job as well as I can and to your satisfaction. I look forward to the next couple of years."

7. To Elect the Vice Presidents

With no new nominations, the existing Vice Presidents were unanimously re-elected

8. To Appoint the Auditors

The Chairman asked that this be deferred, as the existing auditors were becoming more expensive and less efficient and asked that the Management Committee seek quotes from alternative auditors for future years.

This was unanimously agreed by the meeting

10. To transact any other business

There was an emailed question from Paul Brewer

Keith Morgan stated that he has answered the same question two years ago, and Mr Brewer chose not to accept his answer so has resubmitted his question. Keith Morgan stated that he would answer Mr Brewer's question by email so not to interrupt the meeting.

Brian Bennett – confirmed that the rules had not changed and was satisfied with the previous explanations given.

Keith Morgan stated that there were several items that he would like the meeting to be aware of;

In the recent statement from Cardiff Rugby it states that we have not agreed to the terms of a new lease. This is not correct and we have agreed a brief shortterm extension to the lease for a period of three years. We are just waiting for final details to be confirmed by the lawyers. A longer lease has not been granted due to the uncertainty of Welsh Rugby at this time, and we have to protect ourselves and our members.

David Herbert – Given the current circumstances, the state of Welsh Rugby and the pandemic, it has been agreed to grant Cardiff Rugby a three-year lease.

This lease has a change to the leased area and no longer includes the Bowls Club and the Holiday Inn Car Park which will now come back under the control of CAC.

This gives us scope to look at the redevelopment of CAP and securing the future of the Club.

A CAP Redevelopment Company is in the process of being formed, and this is made up of a representative from each section of CAC.

This company will look at the feasibility of what we can do to financially improve CAC and what we can do to improve the stadium. The Management Committee will grant the redevelopment Company an initial budget to look at feasibility studies so we can establish options going forward, while also considering Cardiff Rugby and the WRU as stakeholders of this site. The potential of including Holiday Inn in those discussions is also something under consideration.

P Edwards (Bowls Section) - Will the development panel be up and running by next year?

David Herbert – The feasibility study will take the best part of a year. We do not foresee any change to the operation of the site for three years as we will have to involve planning discussions with the council and bringing in third parties and subsequently a developer.

The company is being set up to protect the Athletic Club and the members in the respect that if any decisions have to be taken, there is a limited company that is taking those decisions and the Athletic Club is one step removed. That company will be wholly owned by Cardiff Athletic Club. It's operations are under strict (control) from Cardiff Athletic Clubs management committee.

Keith Morgan - just to reassure you, as a Bowls section member, one of the six directors of this company is Chris Barrett, your chairman, who has a substantial input into what's going on.

David Allen – Given the financial situation that has been referred to in Professional rugby, what are your criteria for change.

Keith Morgan – The relationship between CAC and Cardiff Rugby has significantly improved. We have to be mindful that there are five sections to be considered. We hope that the current situation can be resolved with some proper funding. This will then lead us all into a position where we are able to begin meaningful discussions about the future.

David Allen – I am concerned that if we need to negotiate a lease for longer than three years, then we need to be negotiating now.

David Herbert – The whole objective here is to provide the grounds for a longterm arrangement with Cardiff Rugby. However, we must take time to ensure that we investigate fully what the site is and could be worth. We need to consider the relocation of the Bowls Club and the provision for the hockey section. With this in mind, we need to ensure that we create a sustainable long-term income, and this will take some investigation and time to ascertain all the facts.

Keith Morgan - The board are fully aware of the fact that we're looking to

develop and grow and the sort of developments we are trying to make, we are keeping them informed every step of the way because they need to be as invested in this as CAC. domain financially. They need to be invested in this project as much as we are.

Fred Davies - Is it key that Cardiff Athletic Club firmly take the lead?

Keith Morgan – It is important that CAC explores all of the possibilities and keeps up with the ever-changing situations.

Peter Christian – Is the development restricted to the North Stand and ancillary areas, or is the whole ground open to negotiation? Could the pitch be rotated?

Keith Morgan - Leaving the pitch where it is the optimum design. The South stand will certainly be looked at in the near future. The North Stand is no longer fit for purpose and is too small. The ideal is that we will have a fit for purpose ground for professional rugby and facilities for the other related teams.

Mervyn John - Will there be an event to celebrate the 100th anniversary of CAC?

Keith Morgan – Agree that this is something that we will look at and hopefully arrange.

With no further questions the Chairman thanked everyone for attending and closed the meeting.

FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MAY 2022

INDEPENDENT REPORT OF THE AUDITORS TO THE MEMBERS OF CARDIFF ATHLETIC CLUB

Qualified Opinion

We have audited the financial statements of Cardiff Athletic Club (the 'club') for the year ended 31 May 2022 which comprise income and expenditure account, Balance Sheet and the related notes, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland (United Kingdom Generally Accepted Accounting Practice).

Except for the possible effects of the matter described in the basis for qualified opinion section of our report, the financial statements:

- give a true and fair view of the state of the club's affairs as at 31 May 2022 and of its income and expenditure for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice.

Basis for qualified opinion

The club receives membership income from various sections who independently control the receipt of their respective membership fees. These membership fees are then paid over to the club. The limitations in terms of accessing electronic systems meant that we were unable to satisfy ourselves concerning the completeness of membership income included in the Income and Expenditure Statement at £69,608. Consequently, we were unable to determine whether any adjustment to this amount was necessary.

We conducted our audit in accordance with International Standards on Auditing (UK) (ISAs (UK)) and applicable law. Our responsibilities under those standards are further described in the respective responsibilities of management committee and auditor section of our report. We are independent of the club in accordance with the ethical requirements that are relevant to our audit of the financial statements in the UK, including the FRC's Ethical Standard, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Conclusions relating to going concern

In auditing the financial statements we have concluded that the committee of management's use of the going concern basis of accounting in the preparation of the financial statements is appropriate.

Based on the work we have performed, we have not identified any material uncertainties relating to events or conditions that, individually or collectively, may cast significant doubt on the club's ability to continue as a going concern for a period of at least twelve months from when the financial statements are authorised for issue.

Our responsibilities and the responsibilities of the committee of management with respect to going concern are described in the relevant sections of this report.

Other information

The other information comprises the information included in the annual report, other than the financial statements and our auditor's report thereon. The management committee is responsible for the other information. Our opinion on the financial statements does not cover the other information and, except to the extent otherwise explicitly stated in our report, we do not express any form of assurance conclusion thereon.

REPORT OF THE INDEPENDENT AUDITORS TO THE MEMBERS OF CARDIFF ATHLETIC CLUB

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If we identify such material inconsistencies or apparent material misstatements, we are required to determine whether there is a material misstatement in the financial statements or a material misstatement of the other information. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact.

We have nothing to report in this regard.

Responsibilities of the committee of management

As explained more fully in the committee of management's responsibilities statement, the committee of management is responsible for the preparation of the financial statements and for being satisfied that they give a true and fair view, and for such internal control as it determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the committee of management is responsible for assessing the club's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the committee of management either intends to liquidate the club or to cease operations, or has no realistic alternative but to do so.

Auditor's responsibilities for the audit of the financial statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We identified and assessed the risks of material misstatement of the financial statements from irregularities, whether due to fraud or error, and discussed these between our audit team members. We then designed and performed audit procedures responsive to those risks, including obtaining audit evidence sufficient and appropriate to provide a basis for our opinion.

We design our procedures so as to obtain sufficient appropriate audit evidence that the financial statements are not materially misstated due to non-compliance with laws and regulations or due to fraud or error.

We are not responsible for preventing non-compliance and cannot be expected to detect non-compliance with all laws and regulations - this responsibility lies with management with the oversight of the management committee.

Based on our understanding of the club and discussion with management we identified financial reporting standards as having a direct effect on the amounts and disclosures in the financial statements.

As part of the engagement team discussion about how and where the club's financial statements may be materially misstated due to fraud, we did not identify any areas with an increased risk of fraud.

Our audit procedures included:

- completing a risk-assessment process during our planning for this audit that specifically considered the risk of fraud;
- enquiry of management about the club's policies, procedures and related controls regarding compliance with laws and regulations and if there are any known instances of non-compliance;
- examining supporting documents for all material balances, transactions and disclosures;
- enquiry of management about litigation and claims and inspection of relevant correspondence;
- analytical procedures to identify any unusual or unexpected relationships;

- specific audit testing on and review of areas that could be subject to management override of controls and potential bias, most notably around the key judgments and estimates, including the carrying value of accruals, provisions, recoverability of trade debtors and revenue recognition, as well as calculation of the deferred income; and
- considering management override of controls outside of the normal operating cycles including testing the appropriateness of journal entries recorded in the general ledger and other adjustments made in the preparation of the financial statements including evaluating the business rationale of significant transactions, outside the normal course of business.

Owing to the inherent limitations of an audit, there is unavoidable risk that some material misstatements of the financial statements may not be detected, even though the audit is properly planned and performed in accordance with the ISAs (UK).

The potential effects of inherent limitations are particularly significant in the case of misstatement resulting from fraud because fraud may involve sophisticated and carefully organised schemes designed to conceal it, including deliberate failure to records transactions, collusions or intentional misrepresentations being made to us.

As part of an audit in accordance with ISAs (UK), we exercise professional judgment and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are
 appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the
 internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the management committee.
- Conclude on the appropriateness of the management committee's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the club's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the club to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31ST MAY 2022

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" including the provisions of Section 1A "Small Entities" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Turnover

Turnover is measured at the fair value of the consideration received or receivable, excluding discounts, rebates, value added tax and other sales taxes.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Taxation

Taxation for the year comprises current and deferred tax. Tax is recognised in the Statement of Income and Retained Earnings, except to the extent that it relates to items recognised in other comprehensive income or directly in equity.

Current or deferred taxation assets and liabilities are not discounted.

Current tax is recognised at the amount of tax payable using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date.

Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.

Timing differences arise from the inclusion of income and expenses in tax assessments in periods different from those in which they are recognised in financial statements. Deferred tax is measured using tax rates and laws that have been enacted or substantively enacted by the year end and that are expected to apply to the reversal of the timing difference.

Unrelieved tax losses and other deferred tax assets are recognised only to the extent that it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits.

A hot sunny day greeted the Finalists in September 2021 which this year was limited to only Doubles competitions due to concerns over whether we would be able to complete our normal tournament schedule.

With the previous year's 2020 Tournament not taking place at all due to COVID-19 concerns the club was delighted to bring members together once again and there was a record number of entries in some categories.

Club Maintenance

The Grounds Maintenance programme headed by Clive Bolton included the installation of security fencing to prevent access to the club's grounds from the adjacent public footpath, drainage works and a CCTV system to deter vandals.

The location of the Courts just across from Cefn On Park means there are a significant number of protected trees overhanging the courts which need regular trimming by specialist contractors and every autumn brings a huge number of leaves to clear across the site.

Clive and his team of volunteers are fully occupied in keeping the playing areas free from slippery wet leaves for quite a few weeks in addition to the regular maintenance needed on the artificial clay courts.

Repairing the club car park is also becoming a regular event as the bad weather causes pot holes right across the whole area. With patching repairs costing £1,280 during the year the long term solution would seem to be in getting the car park tarmaced but with costs anticipated to be in excess of £40,000 this remains a longer term objective for the club.

Social Activities

On the social side the club was delighted to have the opportunity to start using the club house again and this gave our Social Secretary the chance to organise a few events and get members back into socialising with fellow members. The club's main room and stairwell were redecorated during the year – the main room decoration was funded by two very generous long standing members who are quite content to remain anonymous but as a club I think all members would like to express their sincere thanks to them both.

Just before the end of May 2022 the club took delivery of its new honours boards that list all the various winners of the club championships. Many thanks to Simon Stokes for organising this long overdue enhancement to the club house.

The Club's Annual Ball was held in November 2021 attracting around 60 of the movers and shakers within the membership with many members donating raffle prizes to help raise valuable funds for the club. The Lisvane Fun Run was once again hosted by the club with the runners finishing up at the clubhouse for drinks and a barbecue. Once again a variety of members stepped forward to help cooking and serving whilst raising money for club funds. We take the opportunity to raise the profile of the club in the area and let local families who are the keenest participants in the Fun Run see exactly what the club had to offer.

Safeguarding

Safeguarding is an important issue for all sports and the club is committed to prioritising the well-being of all children and any vulnerable adults at risk by promoting safeguarding in our club at all times. We have adopted policies and procedures to minimise risk, deliver a positive tennis experience for everyone and respond appropriately to all safeguarding concerns/disclosures.

Our Safeguarding Officer Emma Reid Jones has been responsible for ensuring the club is fully compliant with the Tennis Wales/LTA requirements and has over the years put many, many volunteer hours into a role that she is passionate about and as a club we are indebted to Emma for her dedication.

Our Role in the Community

We are keen to ensure we contribute to the wider promotion of tennis in our community and our Pay to Play option allows non-members to hire a court for an hour during the less busy times. Participants get the chance to play and the whole experience allows them to see what the club can offer to a new member. As part of the Lisvane and surrounding community we are keen to ensure the club is open and welcoming and seen as a key community asset.

Our location on the fringes of the area mean we are less visible than many other tennis clubs so we have to make a real effort to ensure everyone knows about the club and its activities. Our Club Secretary Victoria Morgan ensures we have regular coverage in Lisvane Link the local magazine and ensures our social media presence is boosted.

Our representatives on the Cardiff Athletic Club (CAC) Management Committee – Jim Allan and Clive Bolton keep the tennis section aware of the bigger picture and the challenges that face CAC whilst ensuring the voices of the tennis members of CAC are reflected.

Finally on behalf of the Tennis Section Committee I would like to thank our members who have supported the club in increasing numbers over the past couple of years and thank all those who have volunteered in various roles to make sure our club remains a friendly and lively part of the Lisvane and surrounding community.

RUGBY CHAIRMAN'S REPORT 2021 - 2021

Last June I was elected as the chairman of our great club. As someone who is acutely aware of the history of Cardiff Rugby, I realise what an honour and privilege this is.

I would like to thank my predecessor Chris Norman for his notable contribution in his five year tenure and for his advice, assistance and support over the last year.

In Spring 2021 the board of Cardiff Rugby Limited decided to change the way it used its Premiership team. A decision that was based on both rugby and economic criteria. After the welcome and extremely well received rebrand from Cardiff Blues to Cardiff Rugby, we would now use the "Rags" as an aid to develop our academy players alongside quality semi professional and regional players. This model comes with its challenges as it is difficult to combine player development with competing for trophies. It requires a buy in from all parties, academy, semi professional as well as the full time professional players.

We have been very fortunate in having Steve Law and Gruff Rees to implement the new model. They have created an environment and produced a culture which allows the academy players to express themselves and have the regional players knocking on David Young's door asking to play for the Rags when they are not required for the first team.

Thanks are due to David Young for ensuring player availability whenever possible throughout the season. We would not have attained the success we did without this help.

Cardiff RFC enjoyed a very successful season reaching the semi finals of the Indigo Premiership Cup as well as winning the league title for the first time since 2008-9. Defeat against our nearest challengers Newport in March made the proposition of us being crowned champions extremely unlikely. However Newport's faltering form at the end of the season gave us an outside chance. A bonus point victory in each of our final four games would ensure us the title. The squad thrived under this pressure gaining the necessary bonus point victories away at Llandovery and Swansea as well as at home against regional rivals Pontypridd and Merthyr.

The league title was a fitting reward for the efforts of all playing and coaching staff throughout the season. Director of coaching Gruff Rees, Head Coach Steve Law, team manager lestyn Williams and the coaching personnel of Craig Everett, Ian Evans, Aled James, Cai Jenkins, Scott Andrews and Dan Fish can feel justifiably proud of their achievement.

Our young academy players included Jacob Beetham, Cameron Winnett, Theo Cabango, Ioan Evans, Ryan Wilkins, Ethan Lloyd, Theo Bevacqua, Rhys Barrett, Efan Daniel, Nathan Evans, Rhys Anstey, Alex Mann and Ehan Fackrell.

In a season that saw many notable performances, there were many highlights. The second half of the September fixture against RGC, victory at Sardis Road and the home win over Aberavon being especially memorable.

Jacob Beetham finished the season as both top points and top try scorer with 142 and 9 respectively.

Alex Everett made most appearances playing in all 25 games winning his club cap in the process.

The other payers to win their caps were Rhys Anstey, Gwilym Bradley, Ethan Lloyd, Sean Moore and James Richards.

Congratulations also to prop Thomas Davies who played his 100th game for the RFC during the course of the season.

Several players have left us at the end of the season. Thank you for your contribution and we wish you well in your future careers.

A number of our players have represented Wales Under 20 in the Six Nations Championship and this Summer's tournament in Italy namely Alex Mann, Rhys Barrett, Nathan Evans, Ethan Fackrell, Cameron Winnett, Efan Daniel, Mackenzie Martin and Mason Grady.

A review of last season would not be complete without noting the contribution of our academy and semi professional players and coaches in Cardiff Rugby's European fixtures in December. Despite the Cardiff Rugby playing squad and coaches being confined to their hotel in South Africa and unable to return home, it was decided to fulfill the European fixtures against French champions Toulouse and English champions Harlequins.

Eleven of the squad selected to play against Toulouse had represented the RFC the previous month against Pontypridd at Sardis Road. The players did themselves and the club proud. Their enthusiasm, courage and skill levels captured the minds and hearts of the Welsh rugby public and made all of us even prouder to be Cardiff supporters.

The players Player of the Year was awarded to Alex Everett who was outstanding throughout the season . We wish Alex well next season with the Cornish Pirates.

The coaches Player of the Year was our top try scoring hooker Alun Rees.

The Chairman's Award winner is our popular physio Dyfri Owen. Dyfri has looked after our players for the last 23 seasons, a remarkable achievement. Thank you for your professionalism and service. Good luck with everything that the future holds.

At the time of writing this report, the future structure of the Premiership remains unclear. The Welsh Rugby Union's preferred model being a nine team division(with RGC being ring fenced)to commence the season after next. How the other eight sides are selected is yet to be determined. We do not know if it will be decided by finishing league positions or split on a geographical basis with two teams per region. The Premiership clubs wish to keep the status quo with twelve teams.

Whichever model is finally implemented it is imperative that Cardiff is one of the chosen sides .We can be assured that all the other clubs will be striving tor the same goal. The challenge is to continue to improve our standards .

Sadly, last season saw the passing of two well loved and respected stalwarts of Cardiff RFC, namely Brian Bennett and Billy Woods. Their contribution to our club is immeasurable and both will be sorely missed.

We are very grateful to the many individuals and organisations whose support is invaluable and allows us to succeed.

May I thank all our sponsors for their generous support. In this difficult financial climate your generosity is greatly appreciated.

The board under chairman Alun Jones and chief executive Richard Holland are fully supportive of the new structure and determined to see it succeed.

The Athletic Club with its chairman Keith Morgan continue to assist and ensure we maintain our heritage obligations.
